Why TheraLith XR?

TheraLith XR is an extended-release nutritional supplement formulated to support and maintain normal urine chemistry.*

At the 2006 American Urological Association (AUA) and World Congress of Endourology (WCE) meetings, researchers from Stony Brook University presented the results of taking TheraLith XR on 24-hour urine chemistry measures. After two months, TheraLith XR significantly decreased urinary oxalate levels by 29% and calcium oxalate supersaturation by 22%, and significantly increased urinary magnesium and citrate levels by 48%. In participants with low baseline levels of magnesium and citrate, TheraLith XR increased these measures by more than 300%. Trial participants tolerated TheraLith XR well, with no side effects. (Schulsinger et al, Abstract # 1538)
